ISO 37301 is a new standard specifying the requirements and guidelines for an effective compliance management system. Certification to this standard shows your organisation's commitment to good governance, transparency, and sustainability.

What is ISO 37301?

ISO 37301:2021 provides requirements and guidelines for establishing, developing, implementing, evaluating, maintaining and improving an organisation's compliance management system. Until now, ISO 19600 has provided the framework for compliance management, however this has now been replaced by the more rigorous Type A ISO 37301:2021.

This internationally recognised standard provides a comprehensive set of requirements and guidelines for creating a robust compliance program that allows an organisation to maintain integrity and trust.

What are the differences between ISO 37301 and ISO 19600?

Many of the core elements of ISO 19600 have been maintained in ISO 37301. Any organisation that has already been following ISO 19600 guidelines will have a head start in complying with ISO 37301.

ISO 19600 was a Type B standard, outlining recommendations, but not specifying requirements. ISO 37301 is a Type A certification standard, providing a certifiable benchmark for compliance systems. It is applicable to:

- Private organisations
- Public organisations
- Not for profit organisations

The standard can be applied to any size and type of organisation, regardless of the nature of their activities. ISO 37301 is flexible in its requirements and recognises that an organisation is responsible for determining the needs of their own system and how to implement the requirements.

What value does ISO 37301 add to your business?

A compliance management system provides a structured approach for an organisation to meet their compliance obligations, including those they are legally required to comply with, such as laws and regulations, and those that they voluntarily choose to comply with, such as internal policies and procedures.

Failing to comply with laws and regulations can result in irreparable damage to a business's reputation. Adherence to compliance obligations is a must for any organisation seeking long term growth.
