## What is ISO 14001?

ISO 14001 helps organisations to better manage their environmental aspects and reduce the associated impacts on a local, national, or international scale.

It has led organisations to adopt a systematic approach to environmental management by implementing systems with the aim of contributing to the environmental pillar of sustainability.

## What value can ISO 14001 add to your business?

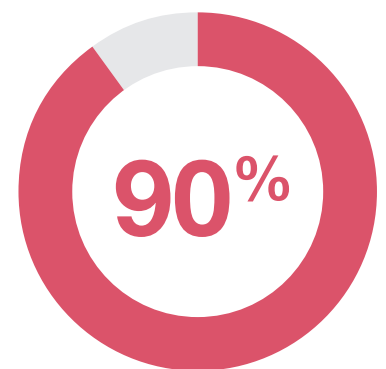
A systematic approach to environmental management can provide top management with tools to build success over the long term, and can create options for contributing to sustainable business practices.
