I, **CRAIG DAVID CROSBIE** of Level 21, 181 William Street, Melbourne, VIC, Chartered Accountant, **MAKE OATH AND SAY** that:

- 1 I am the second plaintiff in this proceeding. Ian Carson and I are the liquidators of:
- (a) the First Plaintiff (**WFL**);
 - (b) Willmott Finance Pty Ltd (ACN 081 274 811);
 - (c) Willmott Forest Products Pty Ltd (ACN 103 019 094);
 - (d) Willmott Forests Investment Management Pty Ltd (ACN 098 718 837) (**WFIM**);
 - (e) Willmott Forests Nominees Pty Ltd (ACN 085 588 772);
 - (f) Willmott Energy Pty Ltd (ACN 130 251 759);



- (g) Willmott Subscriber Pty Ltd (ACN 134 963 027);
- (h) Bioenergy Australia Pty Ltd (ACN 096 335 901);
- (i) Bioforest Limited (ACN 096 335 876); and
- (j) Willmott Notes Pty Ltd (ACN 134 963 036)

(together, **Willmott Group**).

- 2 Except where I otherwise indicate, I make this affidavit from my own knowledge. Where I depose to matters from information and belief, I believe those matters to be true. I am authorised by Mr Carson to make this affidavit on his behalf. Reference in this affidavit to the "Liquidators", "we", "us", "our" or "ourselves" is a reference to Mr Carson and me.

Professional Experience

- 3 I have been a partner of the firm PPB Advisory since 2002. I am a Registered Liquidator and an Official Liquidator of the Court. I am a member of the Institute of Chartered Accountants, the Australian Institute of Company Directors and the Insolvency Practitioners Association of Australia. I also hold a Bachelor of Business. I have worked in corporate insolvency for over 22 years, during which time I have been involved in a number of large and complex external administrations including the administration of the Bill Express group of companies, the Global Campus Management group of companies and the Media World group.

General Background to the Liquidation of the Willmott Group

The Willmott Group and the Willmott Schemes

- 4 WFL acts as the responsible entity and manager of eight schemes that are registered managed investment schemes (**MIS**) pursuant to Part 5C of the *Corporations Act 2001* (Cth) (**Willmott Registered Schemes**) and 22 unregistered (**Willmott Unregistered Schemes**) managed investment schemes (together, **the Willmott Schemes**). There are 6,329 investors in the various Willmott Schemes (**Growers**).
- 5 The Willmott Group's core activities included establishing, managing, harvesting, processing and supplying timber products from plantation grown resources on behalf of shareholders, unit holders and scheme members.
- 6 The Willmott Schemes are operated on land which is either:

- (a) freehold land (approximately 62,000 hectares) owned by WFL or
- (b) leasehold/third party land (over 15,000 hectares), leased or sub-licensed by WFL, or managed by WFL on behalf of third parties.

7 The land on which the Willmott Schemes are operated is located in three primary regional areas:

- (a) softwood pine operations in Bombala and Murray Valley regions in New South Wales and Victoria and throughout the major softwood growing regions of Victoria;
- (b) she-oak and silky oak operations in Northern New South Wales and Southern Queensland; and
- (c) African mahogany operations in the Douglas-Daly region of the Northern Territory.

8 Many of the individual Willmott Schemes are conducted on more than one plantation. Often these plantations are spread across two or three of the primary regional areas. Some Willmott Schemes are conducted solely on freehold land owned by WFL, while others are conducted on both freehold and leasehold/third party land. No Willmott Scheme is conducted solely on leasehold/third party land.

The Appointment of the Administrators and Receivers

9 I refer to the affidavit of Bryan Webster filed in Federal Court of Australia proceeding no. VID 386 of 2011 on 17 June 2011 (**Webster Affidavit**). Now produced and shown to me and marked "CDC-1" is a true copy of the Webster Affidavit (without exhibits).

10 In paragraphs 7 and 8 of the Webster Affidavit, Mr Webster deposes that, on 6 September 2010, he, Mark Korda and Mark Mentha of KordaMentha (**Receivers**) were appointed as joint and several receivers and managers of all of the charged property of the Willmott Group of Companies (**Charged Property**).

11 In paragraph 10 of the Webster Affidavit, Mr Webster deposes that pursuant to Deeds of Partial Termination executed in September and October 2010, the Receivers' appointment to WFL's rights, title and interest in, and rights and obligations arising under any agreement, deed or document appointing WFL as responsible entity and/or manager of the Willmott Schemes (other than in respect of the 'Taylor Singer' partnership schemes, and the 1981 "No Project" schemes). The effect of the Deeds of Partial termination was



to exclude from the Receivers' appointment WFL's role as responsible entity and / or manager of certain of the managed investment schemes operated by WFL.

- 12 In paragraph 12 of the Webster Affidavit, Mr Webster deposes that the Charged Property expressly excludes:
- (a) the freehold land owned by WFL in and around the town of Bombala in New South Wales, comprising 27,861 hectares of land approximately 70% of which had been planted with pine as at 6 September 2010 (the **Bombala Land**);
 - (b) scheme property or trust property associated with the Willmott Schemes; and
 - (c) (following the partial termination of the Receivers' appointment) the responsible entity / manager function described in paragraph 11 above.
- 13 From paragraphs 11 and 12 of the Webster Affidavit I understand that, with the exception of the assets set out in paragraph 12 above, the Receivers currently control all other assets of the Willmott Group.
- 14 On 6 September 2010, Avitus Thomas Fernandez (**First Administrator**) was appointed as voluntary administrator of the Willmott Group of Companies pursuant to section 436A of the *Corporations Act 2001* (Cth) (**the Act**). The First Administrator took control of the non-charged assets, namely the Bombala Land and the Willmott Schemes, including WFL's rights and obligations as responsible entity of the schemes.
- 15 The Secured Creditors applied to the Federal Court for the First Administrator to be removed. On 26 October 2010, the Honourable Justice Finkelstein ordered that the First Administrator be removed as voluntary administrator pursuant to section 449B of the Act on the basis that he did not appreciate the extent of the administrator's task in respect of this administration, he and his staff did not have the capacity to carry out the tasks required to be performed and he did not have the appropriate amount or type of insurance cover. Ian Carson and I were appointed as joint and several voluntary administrators of the Willmott Group on this date.

Liquidation

- 16 On 14 March 2011, we issued the s439A Report to Creditors to Growers and creditors recommending that the Willmott Group be wound up so that the assets could be realised. The Second Creditors meeting held on 22 March 2011 resolved to place the Willmott Group in liquidation and appoint Mr Carson and I as the liquidators.

- 17 In order to wind up the Willmott Group and the Willmot Schemes and obtain the best possible realisation of the assets of both, we considered that it would be necessary to terminate, relinquish, surrender or disclaim the Growers' interests in the Willmott Schemes. This would allow us to sell WFL's interest in the land on an unencumbered basis and sell the trees. We formed this view in part on the basis of legal advice received from our solicitors, Arnold Bloch Leibler (**ABL**). We intended to disclaim the Growers' interests on the basis that the Growers would be entitled to the net proceeds of sale or any other value or consideration received for or referable to the termination, relinquishment, surrender or disclaimer of the Growers' rights.
- 18 On 11 May 2011, we sought directions from the Federal Court in proceeding number VID 386 of 2011 that we would be justified in amending the constitutions of the Willmott Registered Schemes and investment deeds or constitutions of the Willmott Professional Investor Schemes (as those terms are defined in my Third Affidavit, which is exhibited and marked "**CDC-2**" to this affidavit) to empower WFL to terminate, relinquish or surrender the leases, sub-leases, forestry management agreements and other project documents between WFL and Growers (together, the **Project Documents**).
- 19 I swore an affidavit on 11 May 2011 in support of the directions sought from the Federal Court in VID 386 of 2011 (**Third Affidavit**). Now produced and shown to me and marked "**CDC-2**" is a true copy of the Third Affidavit (without exhibits).
- 20 On 29 June 2011, the Honourable Justice Dodds-Streeton made orders justifying those amendments. Now produced and shown to me and marked "**CDC-3**" is a true copy of those orders (without annexures).
- 21 In accordance with the orders granted and by deeds dated 12 July 2011, we caused WFL to amend the constitutions of the Willmott Registered Schemes and investment deeds or constitutions of the Professional Investor Schemes to insert the power to terminate, relinquish or surrender the Project Documents. Now produced and shown to me and marked "**CDC-4**" are true copies of the deeds relating to the HVP Schemes.

Purpose of application

- 22 As stated in paragraph 6(b), above, some of the Willmott Schemes were conducted on land which WFL leases from third parties. Relevantly to this application, part of that leased land includes 13,338 hectares of land situated in Victoria which is leased or sub-licensed from either Hancock Victorian Plantations Pty Ltd (ACN 084 801 132) (**HVP**) or Grand Ridge Plantations Pty Ltd (ACN 004 285 705) (**GRP**) (**HVP Leases**) and then sub-leased by WFL to individual Growers (**HVP Sub-Leases**). My lawyers have conducted



searches of the ASIC records of HVP and GRP, and inform me that those searches show that HVP and GRP are each subsidiaries of Hancock Victorian Plantations Holdings Pty Ltd (ACN 084 801 178). Now produced and shown to me and marked "CDC-5" are true copies of historical searches from the ASIC database of HVP and GRP.

- 23 This affidavit is made in support of an application for orders and directions in relation to the termination of the HVP Leases and the sale of the trees on the land covered by the HVP Leases (**HVP Land**).

HVP Schemes

- 24 Four Willmott Schemes – two registered schemes and two unregistered schemes - were conducted in part on the HVP Land (together the **HVP Schemes**). The HVP Schemes are:

(a) the Willmott Forests Project (ARSN 089 379 975), a registered managed investment scheme, in respect of the following "sub-projects":

- (i) the 2006 Project;
- (ii) the 2007 Project; and
- (iii) the 2007 Premium Forestry Blend Project; and

(b) the Willmott Forests Premium Forestry Blend Project (ARSN 131 549 589), a registered managed investment scheme,

(together the **HVP Registered Schemes**); and

(c) the Willmott Forests - Professional Investor - 2004 Project, an unregistered managed investment scheme; and

(d) the Willmott Forests - Professional Investor - 2006 Project, an unregistered managed investment scheme

(together the **HVP Unregistered Schemes**).

- 25 The constituent documents:

(a) for the Willmott Forests Project are:

- (i) a constitution;
- (ii) a prospectus or product disclosure statement;

- (iii) a lease between the Grower and WFL; and
 - (iv) a forestry management agreement between the Grower and WFL,
- (b) for the Willmott Forests Premium Forestry Bland Project are:
 - (i) a constitution;
 - (ii) a product disclosure statement;
 - (iii) a Land Sourcing and Forestry Management Agreement; and
 - (iv) a Land Tenure Agreement,
- (c) for the HVP Unregistered Schemes are:
 - (i) an investment deed;
 - (ii) an information memorandum;
 - (iii) a lease between the Grower and WFL; and
 - (iv) a forestry management agreement between the Grower and WFL.

26 Now produced and shown to me and marked "CDC-6" is a compact disc containing the constituent documents of the HVP Schemes.

27 Under the Grower lease arrangements in all the HVP Schemes, Growers pay rent to WFL only when the trees are harvested, being a proportion of the harvest proceeds. Under the forestry management arrangements, Growers pay an upfront fee per hectare to WFL in addition to paying a further fee to WFL following the harvest, being a proportion of the harvest proceeds.

28 This application is made, inter alia, in order to seek directions from the Court that:

- (a) we are justified in entering into the Final Implementation Deed (as later defined);
- (b) we are justified in apportioning the consideration payable pursuant to the Final Implementation Deed between us and the Receivers (as defined below) in the terms set out in the Final Implementation Deed;
- (c) we are justified in holding the Liquidators' Consideration (as defined below) on trust until it can be pooled and distributed together with the proceeds of sale from the realisation of other assets of the respective HVP Schemes; and
- (d) we are justified in terminating or surrendering the Growers' rights under the HVP Schemes in respect of the HVP Leases and HVP Land including, but not limited to, the HVP Sub-Leases.

Contractual arrangements


- 29 Shortly after our appointment as administrators to the Willmott Group of Companies, we asked ABL to conduct a review of the contracts in place in respect of all of the Willmott Schemes.
- 30 Relevantly, part of that review included an analysis of the contractual arrangements between WFL (and any other company in the Willmott Group of Companies) and HVP and/or GRP.
- 31 I am informed by Jane Sheridan of ABL that, from that contractual review, it is evident that WFL engaged HVP in order to acquire additional land for the purposes of establishing, promoting and operating the Willmott Schemes and for HVP to provide forestry management services in relation to the trees to be planted on the HVP Land.
- 32 The relationship with HVP is governed by four relevant types of agreements –

Relationship Agreement

- (a) WFL, HVP and GRP entered into a relationship agreement on 22 March 2006 (**Relationship Agreement**). The term of the Relationship Agreement was extended by a deed of amendment dated 14 May 2008. A Second Relationship Agreement was entered into between HVP, GRP, WFL and WFIM on 7 June 2010 (**Second Relationship Agreement**). Now produced and shown to me and marked "CDC-7" are true copies of the Relationship Agreement, the deed of amendment dated 14 May 2008 and the Second Relationship Agreement. The Relationship Agreement sets out the general agreement between WFL, HVP and GRP for the provision of land by HVP to WFL and the establishment and management of pine plantations upon that land.

HVP Leases

- (b) There is a series of leases in relation to portions of land owned or licensed by HVP or GRP (ie the HVP Land) which, in the contractual documents, are referred to as "Tranches". The HVP Leases are in substantially the same terms. Now produced and shown to me and marked "CDC-8" is a true copy of the HVP Lease in respect of "Tranche 1", executed between GRP and WFL and dated 22 March 2006.
- (c) The HVP Leases are for a term of 30 years. The rent/license fees under the HVP Leases was payable by WFL in two distinct instalments;



- (i) an upfront sum calculated per hectare on the commencement of the HVP Lease (**Upfront Rent Portion**); and
 - (ii) a percentage of the proceeds of harvest of the trees on the HVP Land when those trees were harvested (**Harvest Rent Portion**).
- (d) At the time of our appointment as administrators, most of the rent/licence fees payable to HVP and GRP under the HVP Leases were prepaid by WFL pursuant to the Upfront Rent Portion. The Directors' Report as to Affairs dated 6 September 2010 stated that the value of the Upfront Rent Portion on the unexpired term of the HVP Leases was \$31,671,470.12. Now produced and shown to me and marked "CDC-9" is a true copy of the relevant section of the Directors' Report as to Affairs dated 6 September 2010.

Forestry Management Agreement

- (e) There are five forestry management agreements - in substantially the same terms - in relation to groupings of tranches of the HVP Land (**Forestry Management Agreements**). Now produced and shown to me and marked "CDC-10" is a true copy of the Forestry Management Agreement dated 22 March 2006 in relation to Tranche 1.
- (f) Under the Forestry Management Agreements, WFL appoints HVP and GRP to plant, maintain and harvest the trees on the HVP Land. In consideration of HVP and GRP carrying out those services, WFL is obliged to pay GRP an upfront management fee per hectare payable at the commencement of the Forestry Management Agreement, an ongoing annual management fee payable monthly in arrears, a deferred management fee payable as a percentage of the harvest proceeds of the trees on the HVP Land and GRP's defined direct costs.

Forestry Property Agreement

- (g) There is also a series of forestry property agreements in relation to distinct tranches of the HVP Land between HVP or GRP and WFIM (together **Forestry Property Agreements**). Now produced and shown to me and marked "CDC-11" is a true copy of the Forestry Property Agreement in relation to Tranche 1 of the HVP Land, dated 29 March 2006.
- (h) The Forestry Property Agreements are purported to be "Forestry Property Agreements" for the purposes of the *Forestry Rights Act 1996* (Vic). Under the



Forestry Property Agreements, HVP or GRP grants all interest in the trees on the relevant HVP Land to WFIM as agent on behalf of the Growers in the HVP Schemes (subject to payment of the rent pursuant to the HVP Leases).

- 33 Now produced and shown to me and marked "CDC-12" is a compact disc containing electronic copies of all of the HVP Leases, the Relationship Agreement (and amendment deed to it), the Forestry Property Agreements and the Forestry Management Agreements.

Control over the HVP Leases

- 34 At paragraph 111 of the Webster Affidavit, Mr Webster deposes that:

"the Receivers' appointment extends to WFL's rights and interests under any lease, sub-leases, licences and sub-licences of land, including any such rights and interests in respect of the land leased from HVP (HVP Leases)."

- 35 My understanding is that this statement is predicated upon the position that the HVP Leases are not scheme property.

Notices of Breach

- 36 By letter dated 6 October 2010 from Mallesons Stephen Jaques (the solicitors for HVP and GRP), five separate notices of breach were issued by HVP and GRP to WFL and WFIM. Now produced and shown to me and marked "CDC-13" is a true copy of the letter and enclosed notices of breach dated 6 October 2010. Those notices are in substantially the same form and were issued in respect of the non-payment by WFL and WFIM of invoices issued by HVP and GRP pursuant to the Forestry Management Agreements. The notices demanded that WFL and WFIM make payment of the outstanding invoice amounts within 15 days of the date of the notice. They also noted that, if WFL did not comply with the relevant notice, HVP or GRP was entitled to terminate the relevant Forestry Management Agreement.
- 37 Further notices of breach dated 11 November 2010, 16 December 2010, 20 January 2011 and 11 February 2011 were issued by HVP or GRP to WFL. Now produced and shown to me and marked "CDC-14", "CDC-15", "CDC-16" and "CDC-17" respectively are true copies of the bundles of notices of breach dated 11 November, 16 December 2010, 20 January 2011 and 11 February 2011.
- 38 From August 2010 to 28 February 2011, more than \$2.9 million (including GST) in management fees were unpaid by WFL to HVP and GRP. At the time of receipt of the various notices of breach, WFL was not in a position to rectify the breaches, and on that

basis HVP and GRP had the right to terminate the HVP Leases in accordance with clause 15.2 of the HVP Leases.

39 I understand from ABL that HVP and GRP had the right to terminate each of the HVP Leases immediately upon Mr Fernandez's appointment as voluntary administrator of the Willmott Group of Companies on 6 September 2010, and also the appointment of the Receivers on the same date.

40 I also understand from ABL that if the HVP Leases terminate, the Forestry Management Agreements and Forestry Property Agreements also terminate automatically, and that the HVP Sub-Leases will also terminate, subject to any right to seek relief against forfeiture.

Expression of Interest Campaign

41 In November 2010, we commenced our expressions of interest campaign calling for expressions of interest from third parties in taking over as RE of the Willmott Schemes. We received four indicative nonbinding conditional offers. None of those bidders was willing to fund the costs of managing the schemes during the period of any delay for the satisfaction of conditions, which included finance and further due diligence periods.

HVP Offer

42 We also received a binding offer from HVP to the Expressions of Interest Campaign. The offer related only to the HVP Schemes. The proposal involved collapsing the relevant schemes to create one new scheme. We considered this would have been complex and have taken a considerable time to implement. The proposal did not provide for replacement of the responsible entity and therefore would have involved WFL's continued involvement or identification of a third party willing to take on those responsibilities.

43 We sought an extension of the convening period to enable, amongst other things, the negotiations with HVP to take place during the statutory administration moratorium to avoid the risk of termination of the HVP Lease. On 8 February 2011 the Federal Court granted the extension.

44 On 16 February 2011, we received an alternative binding offer from HVP (**Preliminary HVP Offer**). Now produced and shown to me and marked "**Confidential CDC-18**" is a true copy of the Preliminary HVP Offer. In the Preliminary HVP Offer, HVP offered an amount for the acquisition of the trees occupying the HVP Land and termination or surrender of all leases, sub-leases, licenses, sub-licenses and sub-sub-licenses in respect of the land the subject of the HVP Leases.

45 Following receipt of the Preliminary HVP Offer, we negotiated with HVP with a view to improving the offer. We were also in discussions with the Receivers in relation to the Preliminary HVP Offer and the respective rights of WFL in its own capacity and the Growers in relation to the HVP Leases. The Receivers indicated to us that they would not be a party to any agreement in relation to the HVP Leases unless any consideration paid was expressly apportioned between WFL in its own capacity and the Growers. It was apparent to us that agreement as to any such apportionment would take time and would be unlikely to be reached within the time available prior to the end of the statutory administration moratorium.

46 In negotiating with HVP, we considered there should be some consideration for:

(a) the value of the Upfront Rent Portion on the unexpired term of the HVP Leases, which were included as an asset in the financial statements of WFL prepared, audited and lodged by WFL prior to our appointment. In considering some value should be ascribed to these rental fees, I assumed that the fees would be recoverable against HVP or that, if we sought to assign the HVP Leases to a third party, that party would ascribe some value to the fees; and

(b) the trees.

47 On 23 March 2011, we received a letter from HVP agreeing to increase the sum payable, for the acquisition of the trees on the HVP Land, and full surrender or termination of the HVP Leases and Grower interests in the HVP Land (**HVP Payment**). Now produced and shown to me and marked "**Confidential CDC-19**" is a true copy of that letter (**HVP Offer**).

48 In or around April 2011, we engaged Poyry Management Consulting (Australia) Pty Ltd (**Poyry**) to consider the reasonableness of the HVP Offer. Poyry issued that report on 19 April 2011 (the **Poyry HVP Report**). Now produced and shown to me and marked "**Confidential CDC-20**" is a true copy of the Poyry HVP Report. We consider that memorandum should be kept confidential except to the extent referred to in this affidavit. Should this application be unsuccessful, we would need to negotiate with HVP to determine whether it would allow us to sell any interests in the HVP Leases and HVP Land, including the trees, to a third party. We would not want to jeopardise the price we would be able to achieve in any future sale through the disclosure of the Poyry HVP Report.

49 According to the Poyry HVP Report, the trees on the HVP Land have an average age of 2.5 years with an expected average clearfell age of 29.6 years. Accordingly, the trees generally have another 27 years to grow before being harvested. The net present value

ascribed to the trees in the Poyry HVP Report is based on the assumption that the HVP Schemes will continue for the additional 27 years until harvest on the basis of the scheme documents (ie, without the need for further rent to be paid until harvesting of the trees).

50 Poyry concluded that the HVP Offer was reasonable.

51 However, Poyry were not asked to, and did not, consider what value, if any, should be ascribed to the termination or surrender of the HVP Leases, as this was not within the scope of Poyry's expertise.

52 In considering what value should be ascribed to the HVP Leases, we considered what would be likely to be paid for the HVP Leases in a sale or assignment of the leases to a third party. On the basis of our experience in insolvency situations, third parties who acquire leases have regard to what rental has been paid or will be payable in future. In this case, rental of more than \$30 million had been paid for the unexpired term of the lease. We considered that a third party would be prepared to pay a significant amount to obtain the benefit of \$30 million of prepaid rent, even assuming a liquidator's "firesale".

53 We also had regard to the fact that the Receivers had informed us that, should the HVP Leases be terminated, the Receivers would seek to establish a right to be repaid the prepaid rental. While we understood that their ability to do so was not an express term of the HVP Leases, we considered that the costs and uncertainty of litigation may lead to HVP and the Receivers reaching an agreement in this regard.

54 We considered that the HVP Offer represented the best value to Growers in relation to the HVP Leases for the following reasons -

- (a) The HVP Leases were at risk of termination due to the outstanding \$2.9 million of fees and the inability of WFL to pay the outstanding amount or other amounts which become due and payable under the HVP Leases.
- (b) Should the HVP Leases and HVP Sub-Leases be terminated, WFL and/or the Growers would have three months to remove the trees from the HVP Land, otherwise the trees would be considered abandoned. As stated above, according to the Poyry HVP Report the trees on the HVP Land are, on average, only 2.5 years and will not be ready to be harvested for 27 years. I understand from Stephen Addicott, WFL Forestry Manager, that there is little to no value in the trees in their present condition and the costs of harvesting the trees would far outweigh the present value.



- (c) On termination, HVP would also be entitled to the loss and damage from WFL arising from the early termination of the HVP Leases and Forestry Management Agreements. HVP would be entitled to harvest the trees to recover this loss and damage.
- (d) Should Growers wish to claim relief against forfeiture, I understand that they would need to immediately pay the outstanding costs and fees of \$2.9 million and agree to continue to pay the costs and management fees for the remaining life of the agreements. I considered a Court would also be unlikely to grant relief against forfeiture unless all Growers applied for relief against forfeiture and/or agreed to take over all parcels of land leased by WFL from HVP. Further, I considered that it was inherently unlikely that the Growers would be prepared to and/or be able to assume and meet WFL's ongoing liabilities in respect of the HVP Leases and HVP Land.



55 For these reasons we accepted the HVP Offer and, on 19 April 2011, we executed an Implementation Deed with HVP and GRP to set out the steps to effect the HVP Offer (**Implementation Deed**) and to prevent further management fees from accruing. However, as we had not been able to obtain the consent of the Receivers prior to the execution of the Implementation Deed, the Receivers were not a party to the Implementation Deed. It was a condition precedent to that Implementation Deed that the Receivers and Secured Creditors provide releases in connection with the surrender of the HVP Leases.

56 Since that time we sought to satisfy the conditions precedent, including the obtaining of releases from the Receivers and Secured Creditors. However, the Receivers indicated that they and the Secured Creditors would not agree to providing the necessary releases unless the amount of consideration they would receive in respect of the surrender of the HVP Leases and provision of the releases was agreed upfront.

57 This effectively meant that we needed to determine how the HVP Payment would be apportioned. We continued to negotiate the apportionment questions with the Receivers. These negotiations have been complex and protracted. Details of our negotiations with the Receivers on the apportionment question are set out in more details in paragraphs 61 to 89 below.

58 Throughout this period, HVP and GRP were concerned to reduce the length of time these negotiations were taking. I, together with members of my team, remained in regular contact with HVP and GRP. I understand that ABL remained in contact with Mallesons.

- 59 The Implementation Deed remained in force during these negotiations. The Implementation Deed included as conditions precedent dates by which certain events had to occur. We needed to agree an extension to these dates on a number of occasions with HVP and GRP.
- 60 In or around September 2011, HVP informed us that it would need to obtain board approval if the parties sought any further extension of the dates in the conditions precedent. HVP indicated that it would only seek board approval for an extension if there had been sufficient progress in our negotiations with the Receivers.
- 61 We agreed with HVP, GRP and the Receivers that a new implementation deed be executed to replace the original Implementation Deed. I understand that protracted negotiations then ensued between the Receivers and HVP around the terms of the releases and the solicitors for each party were also finalising the terms of the new implementation deed.
- 62 Negotiations successfully concluded on 30 November 2011 and, on that date we, HVP, GRP and the Receivers executed an amended and updated version of the Implementation Deed (**Final Implementation Deed**). Now produced and shown to me and marked "**Confidential CDC-21**" is a true copy of the Final Implementation Deed.
- 63 The conditions precedent to the Final Implementation Deed relevantly require:
- (a) a Court order that the Liquidators are justified in implementing the Final Implementation Deed and taking the steps contemplated by the deed, such order to be obtained by 31 January 2012;
 - (b) a Court order that the Liquidators were justified in their determination and allocation of the Growers' portion of the Consideration (defined in paragraph 88, below) such order to be obtained by 31 January 2012;
 - (c) the "Releasing Parties" (WFIN, MIS Funding No. 1 Limited, the Commonwealth Bank of Australia and CBA Corporate Services (NSW) Pty Limited) to provide acceptable releases before implementation; and
 - (d) release, extinguishment or relinquishment of the Project Documents by the Liquidators.



Apportionment of proceeds of the Final Implementation Deed

64 In this affidavit, I will refer to the payment by HVP and GRP to us and the Receivers under the Final Implementation Deed as the "**Consideration**".

65 As set out above, the Receivers would not agree to provide a surrender of the HVP Leases and the Receivers and Secured Creditors would not provide the releases required in the conditions precedent without agreement on the amount payable to them in consideration for the surrender and releases. It was therefore necessary for us to determine and agree on apportionment of the Consideration prior to executing the Final Implementation Deed.

66 The following issues arose in determining how the Consideration should be apportioned:

- (a) whether the HVP Leases constituted "scheme property" - set out in paragraphs 67 - 83 below;
- (b) determining apportionment of the Consideration as between Growers and Secured Creditors on the basis of the scheme property question and lease/tree allocation - set out in paragraphs - 84 to 89 below;
- (c) allocating and deducting our costs from the Consideration - set out in paragraphs 91 - 95 below; and
- (d) the payment of funds to Growers - set out in paragraphs 96 - 100 below.

Whether HVP Leases are "scheme property"

67 In paragraph 21 of my Third Affidavit, I state that:

"I am told by Jane Sheridan of ABL that, as the Leasehold Land is used for the purposes of one or more Schemes, it is arguable that the HVP and FNSW Leases constitute scheme property rather than assets of WFL in its personal capacity. The Receivers have indicated that they consider that the HVP Leases are assets of WFL in its personal capacity. This question may need to be determined in the allocation of the proceeds of any sale of the interests in the Leasehold Land as between the Secured Creditors and the Growers or if a compromise is reached, the compromise approved."

68 Since the date of my Third Affidavit, discussions have been ongoing between the Liquidators and the Receivers regarding whether the HVP Leases are properly construed



as "scheme property" or the property of WFL in its personal capacity (**Scheme Property Question**).

69 I understand that Ms Sheridan's advice was that it was arguable that the HVP Leases were scheme property was based on instructions from us that we believed the prepaid rent may have been paid using Grower funds. As set out below, following our review, we do not consider Grower funds were in fact used to fund the HVP Leases.

70 I understand from Ms Sheridan that Growers in the HVP Schemes paid an amount on application for their interest. That amount was the sum that Growers were required to pay to WFL under their forestry management agreement with WFL for preparation and planting of their Woodlot. An additional management fee, being a percentage of the harvest proceeds, was payable on harvesting the trees. The Growers were not required to prepay rent under their lease of the Woodlot. The rental under the lease was a proportion of the harvest proceeds and was only payable on harvesting.

71 I understand that the term "scheme property" is defined in section 9 of the Act to mean:

- (a) contributions of money or money's worth to the scheme; and
- (b) money that forms part of the scheme property under provisions of this Act or the ASIC Act; and
- (c) money borrowed or raised by the responsible entity for the purposes of the scheme; and
- (d) property acquired, directly or indirectly, with, or with the proceeds of, contributions of money referred to in paragraphs (a), (b) or (c); and
- (e) income and property derived, directly and indirectly, from contributions, money or property referred to in paragraphs (a), (b), (c) or (d).

72 I was advised by Ms Sheridan that, in order to assist in the determination of whether the HVP Leases are scheme property, we should analyse the source of the funds to pay the HVP Leases to determine whether they were funded by Growers or otherwise.

73 We therefore conducted an analysis of the cash flows within the Willmott Group of Companies in order to attempt to clarify whether the HVP Leases were financed with money from Growers in the HVP Schemes.



- 74 Angela Clancy of my office undertook that analysis. I am informed by Ms Clancy and believe the matters to which I depose in paragraphs 75 - 82, below.
- 75 Ms Clancy of my office prepared a memorandum dated 23 September 2011 in relation to our analysis of the cash flows within the Willmott Group of Companies as relevant to the Scheme Property Question. Now produced and shown to me and marked "**Confidential CDC-22**" is a true copy of that memorandum (**PPBA Memorandum**).
- 76 The prepaid rent to HVP and GRP in respect of the HVP Leases was paid out of WFL's day-to-day trading account (**the Trading Account**). In analysing the Trading Account statements, it appears that a wide variety of other payments were made from the Trading Account including wages, other rent, entertainment expenses and miscellaneous expenses such as petty cash. Concurrently, the Trading Account statements also show various sources of funds into the Account. Whilst Ms Clancy was unable to accurately identify all sources of funds, it appears WFL received transfers from specific scheme accounts and from Willmott Finance Pty Ltd, drawdowns from bank facilities, sale proceeds relating to the sale of grower loan receivables and refunds from the Australian Taxation Office into the Trading Account. Due to the variety of funds coming in and going out of the Trading Account, it is not possible to accurately trace the transfer of payments into and out of the Account.
- 77 I am told by Ms Clancy and believe that the amount paid by Growers in the HVP Schemes on lodging an application for an interest in a Scheme was paid into a trust account specific to that scheme (**the Scheme Accounts**). Funds would be transferred out of the Scheme Accounts and into the Trading Account, once Growers were allocated a woodlot, in payment of the upfront management fee payable by Growers to WFL under their forestry management agreement (I understand that this in accordance with WFL's obligations).
- 78 In undertaking the tracing exercise, Ms Clancy analysed the amount of Grower funds that would have been received (pursuant to the number of Growers and amount payable on application) into the Scheme Accounts and subsequently transferred into the Trading Account (**Transferred Funds**), and compared it to the availability of funds in the Trading Account during the period from the commencement of the scheme and up until the payment(s) to HVP and GRP (**the Tracing Period**). This analysis did not consider the express purpose for which the Transferred Funds had been paid, that is in payment of the upfront management fee under the Growers forestry management agreement to cover the preparation and planting costs, but simply assumed that the Transferred Funds were used, to the maximum extent possible, to pay the rental due under the HVP Leases. It

also did not distinguish between amounts paid by Growers who were allocated a lot on HVP Land and Growers who were allocated a lot on WFL owned land. Given that the HVP Schemes were conducted on both HVP Land and WFL owned land, it was not possible to distinguish between Growers payments on the basis of the existing financial records.

79 Ms Clancy operated on the assumption that the maximum amount of Transferred Funds available in the Trading Account were used to pay HVP and GRP. This amount was calculated by identifying the lowest balance of funds in the Trading Account during the Tracing Period (this is referred to as the closing balance test). However, there was no evidence to suggest that Transferred Funds were treated any differently from other funds in the Trading Account and/or that Transferred Funds were preferred over other funds to pay for the HVP Leases. It was therefore just as likely other funds were used to pay the HVP Leases. In this case, a proportional tracing exercise (whereby all funds in the Trading Account would be traced into the HVP Leases proportionate to their value) would have been more appropriate.

80 I am told by Ms Clancy and believe that it is not clear from the documentation available as to which HVP Scheme each of the payments to HVP in relation to the HVP Leases related to. Therefore, two alternative traces of the Transferred Funds were conducted, each on the basis of different assumptions, being:

- (a) that payments made to HVP/GRP on or around 30 June were in respect of leases of land to be used for the HVP Scheme which, at that point, was one year mature (**Assumption One**); and
- (b) that payments made to HVP/GRP on or around 30 June were in respect of leases of land to be used for the most recent HVP Scheme (**Assumption Two**).

81 Noting the above difficulties with tracing payments into and out of the Trading Account, Ms Clancy concluded that:

- (a) on the basis of Assumption One, at best \$8,628,045 of Transferred Funds could have been used to pay HVP/GRP, representing 23.05% of the monies paid to HVP; and
- (b) on the basis of Assumption Two, at best \$17,950,244 of Transferred Funds could have been paid to HVP/GRP, representing 47.96% of the monies paid to HVP/GRP.



82 As stated above, the closing balance test may not have been the most appropriate method of tracing. If another tracing method was used, such as the proportionate tracing method, then a lower amount than the above figures would have resulted. A figure as low as \$0 could have resulted. I understand that Ms Clancy also assumed in undertaking their tracing exercise that all Grower funds (for Growers in the HVP Schemes regardless of whether they were allocated HVP Land) were received into the Scheme Accounts and also that all those funds were then paid out of the Scheme Accounts and into the Trading Account. This may not have occurred.

83 We concluded it would be difficult to establish that the HVP Leases were scheme property.

Consideration as between the trees and the HVP Leases

84 If the HVP Leases are not Scheme Property, then in relation to the Consideration, the Receivers would be entitled to the value referable to the termination of the HVP Leases (as well as any value referable to the releases to be provided by the Secured Creditors) and the Growers would be entitled to the value referable to the trees.

85 As set out in paragraph 48 above, the Poyry HVP Report provided a value for the trees (not including a land holding cost and assuming the Scheme continued for its intended duration) in considering the reasonableness of the HVP Offer. We considered this was the maximum value of the Growers' claim.

86 Based on the assumption that the Upfront Rent Portion relating to the unexpired term of the HVP Leases was either recoverable from HVP on termination or payable by a third party on an assignment of the HVP Leases, we considered that amount to represent the maximum value of the Receivers' claim.

87 We negotiated with the Receivers for a number of months in trying to reach agreement on an allocation of the Consideration between Growers and Receivers based on the above claims.

88 Negotiations concluded with an agreement that the Growers would be entitled to 30% of the Consideration (**Liquidators' Consideration**) and the Secured Creditors entitled to 70% of the Consideration (**Receivers' Consideration**).

89 On the basis of:

- (a) our financial analysis in relation to the purpose of Grower's application monies and the tracing exercise;

- (b) the financial difficulties faced by WFL and its resulting inability to continue to operate the HVP Schemes or pay amounts owing or which would become owing under the HVP Leases;
- (c) the risk of termination of the HVP Leases and consequent effect on Growers;
- (d) the legal advice we received during the course of negotiations with HVP and the Receivers; and
- (e) the risks that Growers may otherwise receive nothing for their investment,

we concluded that the Final Implementation Deed, including the apportionment of the Consideration, was in the best interests of the Growers.


90 As the advice we have received from our lawyers has been both oral and written over the past twelve months, I have instructed our lawyers to seek the written advice of Senior Counsel as to the reasonableness of this agreement prior to the hearing of this application. I intend to provide any advice received to the Court as a confidential exhibit to a further affidavit in support of this application

Deducting costs from the Consideration

91 The constitutions of each of the HVP Registered Schemes make provision for costs properly incurred by the responsible entity to be indemnified out of the Schemes' assets. Now produced and shown to me and marked "CDC-23" and "CDC-24" are true copies of the constitution of the Willmott Forests Project and of the Willmott Forests Premium Forestry Blend Project respectively. Clause 8.4 is in substantially the same terms in each of those two constitutions, and provides that, "[t]he Manager is entitled to be indemnified out of the Assets for any liability or expense incurred by it in properly performing or exercising any of its powers or duties in relation to the Project."

92 I understand that, for the two HVP Registered Schemes, section 601FH of the Act is also relevant in relation to our indemnity rights.

93 Identical provisions to those in the constitutions are set out in clause 8.4 of each of the Investment Deeds of the HVP Unregistered Schemes. Now produced and shown to me and marked "CDC-25" and "CDC-26" are true copies of the Investment Deeds of the Willmott Forests - Professional Investor - 2004 Project and the Willmott Forests - Professional Investor - 2006 Project respectively.



94 In light of the matters set out in paragraphs 91 - 93 above, we intend to deduct our costs incurred in realising the HVP assets from the Liquidators' Consideration. We estimate these costs to be in the region of between \$450,000 to \$500,000.

95 I understand that the Receivers intend to deduct their costs out of the Receivers' Consideration.

Payment of funds to Growers

96 As set out in paragraph 8 above, many of the Willmott Schemes are conducted on more than one plantation. Often these plantations are in completely different regions. In relation to the HVP Schemes:

(a) Growers in the Willmott Forests Project were allocated either Bombala, Murray Valley, North Coast, HVP or FNSW Land;

(b) Growers in the Willmott Forests Premium Forestry Blend Project were allocated either North Coast, HVP or FNSW Land;

(c) Growers in the Willmott Forests - Professional Investor - 2004 Project were allocated either Bombala, Murray Valley or HVP Land; and

(d) Growers in the Willmott Forests - Professional Investor - 2006 Project were allocated either Murray Valley or HVP Land.

97 In each of those schemes, Growers were allocated a specific woodlot of land and owned the trees on that particular woodlot. Woodlots were allocated to Growers following the receipt of that Grower's application and the execution of the relevant documentation. Growers would have no control over the allocation of their lot and had no power to reject the allocation.

98 We are currently in the process of completing a sale of the Bombala, Murray Valley, North Coast Land and FNSW Leases (including trees) and expect to bring an application for the approval of a sale contract and apportionment of the proceeds shortly.

99 I understand from Ms Sheridan that the HVP Schemes provide for pooling on a scheme-by-scheme basis (or project-by-project basis for the Willmott Forests Project which has multiple projects).

100 We therefore consider it appropriate that the Liquidators' Consideration (less costs) should be apportioned between the HVP Schemes (proportionate to the number of hectares issued to each of the HVP Schemes) and then each portion held on trust by us.

101 Once the proceeds of sale from the sale of the other assets have been allocated and apportioned between the Willmott Schemes, we intend to pool the two separate funds for the HVP Schemes to be distributed to Growers in proportion to their respective holding within the relevant Pool or Project year. In this way, Growers in each of the HVP Schemes will receive the same return per hectare as other Growers in the same scheme or project, regardless of whether the individual Growers' lots were on HVP Land or land owned by WFL.

Conclusion

102 We consider that the deal embodied in the Final Implementation Deed is in the best interests of Growers in light of the following circumstances -


- (a) HVP and GRP have a right to terminate the HVP Leases, Forestry Management Agreements and Forestry Property Agreements based on WFL's breaches of the agreements, including by failing to pay maintenance fees and direct costs.
- (b) WFL is insolvent and is unable to rectify the breaches.
- (c) Should HVP and GRP terminate the agreements, WFL and/or Growers would have three months to remove the trees from the HVP Land. All interests would terminate after this time.
- (d) Growers could only claim relief against forfeiture or step into WFL's rights as lessee if they agreed to immediately pay all outstanding management fees and direct costs to HVP and GRP and agreed to continue to pay the fees and costs for the remainder of the HVP Leases. We estimate these costs are more than the value of the trees. We also considered a Court would only grant relief against forfeiture if the Growers sought to take over all parcels of land which form part of the HVP Leases.
- (e) Should HVP and GRP terminate the agreements, it is likely that the Receivers will claim and may be entitled to repayment of all or part of the value of the Upfront Rent Portion relating to the unexpired term of the HVP Leases. Alternatively, this sum represents what an arm's length third party would pay WFL for the assignment of its rights under the HVP Leases.



- (f) The Growers would have difficulty in establishing the HVP Leases were scheme property.
- (g) The amount of the Consideration payable to the Growers is substantially more than the value of the trees (based on the Poyry HVP Report less the estimated land holding cost).
