- A. On 15 May 2017 the Parties reached agreement to settle the Proceeding and signed a Deed of Settlement to give effect to that agreement (**Deed of Settlement**).
- B. The Deed of Settlement contemplates that the parties will enter into a separate Call Option agreement to give effect to certain obligations in the Deed of Settlement (a Call Option). The parties are presently negotiating the terms of a Call Option and expect to shortly reach agreement on the terms of the Call Option.
- C. Once the parties agree upon the terms of the Call Option, the Defendants intend shortly thereafter making an application to the Court seeking orders pursuant to section 477(2B) of the

Corporations Act 2001 (Cth) in respect of the Deed of Settlement and the Call Option (**Defendants' Application**).

- 1. The hearing of the Defendants' Application listed on 24 May 2017 is adjourned to 8 June 2017 on an estimate of one to two hours.
- 2. The Defendants give notice of the Defendants' Application to the creditors of the First Defendant and persons interested in the liquidation of the First Defendant, within one business day of filing the Defendants' Application and any affidavit in support of the Defendants' Application (the Defendants' Materials), and in any event no later than 4:00 pm on Friday 26 May 2017:
 - (a) by causing a copy of the Defendants' Materials and these Orders to be served on:
 - (i) the Plaintiff;
 - (ii) the Willmott Committee of Inspection;
 - (iii) Mark Korda, Bryan Webster and Mark Mentha of Korda Mentha, in their capacities as Receivers and Managers of the First Defendant; and
 - (iv) the Australian Securities and Investments Commission;
 - (b) by causing a copy of the Defendants' Materials and these Orders to be published on the website of the Second and Third Defendants (https://www.ppbadvisory.com/creditor-information/v/250/willmott-forests-ltd-receivers-and-managers-appointed-in-liquidation).
- 3. Any person who wishes to participate in the hearing of the Defendants' Application (Interested Person) must file and serve:
 - (a) an appearance;
 - (b) any affidavit; and
 - (c) any written submission, which shall not exceed 10 pages in length, by 4:00 pm on 2 June 2017.
- 4. The Defendants file and serve on any Interested Person:
 - (a) any affidavit in reply; and
 - (b) any written submissions, which shall not exceed 10 pages in length, by 4:00 pm on 6 June 2017.

- 6. Costs are reserved.
