



CONFIRMATION OF END OF DEED

Recitals

- A On 23 December 2016, Willmott Forests Limited (Receivers and Managers Appointed) (In Liquidation) (WFL) and Southern Cross Forests Pty Ltd atf Southern Cross Forests Trust (SCF) entered into a Put and Call Option Deed to Purchase Land and 95-99 Trees, NSW and Victoria (the Deed).
- B The Deed is conditional upon, amongst other things, WFL satisfying the Disclaimer Condition (as that term is defined in the Deed).
