## **Background**

The Company is the owner of land located near Bendigo, Victoria (**the Land**). In 2011, Midland HWY Pty Ltd (In Liquidation) (**Midland**) sold c700 option deeds and c107 off-the-plan land sale contracts for parcels of the Land owned by the Company.

Creditors may be aware we were also appointed Liquidators of Midland on 3 December 2015 by order of the Court following our prior appointment as Voluntary Administrators on 2 July 2015.

## What next?

As Liquidators of the Company, we have a duty to investigate the affairs of the Company. As part of this, we have demanded the Company's books and records from the relevant parties which we will review upon receipt.

We intend to lodge a report of our findings with ASIC pursuant to s533 of the *Corporations Act* 2001 (Cth) within 6 months of our appointment.
