Mr Crosbie paid his respects to their elders past, present and emerging. Mr Crosbie extended that respect to the Aboriginal and Torres Strait Islander peoples attending the Meeting.
	Mr Crosbie confirmed that on 19 January 2022 the directors of the Company appointed Stephen Longley and himself as Joint and Several Administrators of the Company pursuant to Section 436A of the Act.
	Following applications by the Administrators on 16 February 2022 and 12 August 2022, the Court extended the convening period for the Meeting first to 17 August 2022 and then to 30 November 2022.
	 The main purpose of those extensions was to provide sufficient time for the Administrators to: oversee the client transition process; conduct their investigations into the Company's business, property, affairs and financial circumstances; determine a methodology to quantify claims of former DASS clients; and assess any Deed of Company Arrangement proposal put forward and determine if such a proposal should be recommended to creditors.
<u>PURPOSE OF</u> <u>MEETING:</u>	Mr Crosbie advised that this was the second meeting of creditors of the Company since the Administrators' appointment.
	Mr Crosbie informed creditors that, ordinarily, the primary purpose of the second meeting of creditors was for creditors to consider the future of the Company and to resolve one of the following in relation to the Company:
	 that the Company execute the proposed DOCA; or that the Company be wound up; or that the Administration should end (in which case, control of the Company's affairs would be handed back to the director).
	Nevertheless, Mr Crosbie advised that the Administrators were aware that a number of creditors were having difficulties registering for the Meeting on the Creditor Portal and therefore decided it was appropriate to adjourn the Meeting until 16 December 2022 to ensure all eligible creditors could register and attend. Furthermore, Mr Crosbie confirmed that a tutorial would be conducted immediately after the Meeting today to assist creditors to register on the Creditor Portal.
