### Logging into the portal.

1). Open the following link: <u>https://pwc.portallink.com.au/dixon</u>

2). On the top right corner of the letter you received by email on 25 January 2022 for the first creditors meeting, you will find your HRN (highlighted in yellow in the below screenshot). The HRN is the letter "X" followed by a sequence of numbers. If you have not been issued a HRN or cannot locate the HRN details originally issued to you then please contact us via email at au\_dass\_queries@pwc.com

Please note, as stated on the portal, that for the purposes of the first meeting, you do not need to substantiate your debt, and the Administrators will admit you for \$1 in order to vote.
