PAS Group of Companies as per attached schedule (Appendix A) (All Administrators Appointed) ("the PAS Group")

We refer to the notice regarding the Committee of Inspection (**COI**) published on our website and sent to you by email on 10 June 2020.

At the First Meeting of Creditors, the Administrators will propose the following resolution:

"That a committee of inspection be appointed in the administration of The PAS Group Limited (Administrators Appointed) to operate as if it is the committee of inspection for each PAS Group company in administration."

The resolution reflects orders the Administrators obtained in the Federal Court of Australia on 9 June 2020, which:

- dispensed with the requirement that creditors resolve that a committee be formed for each PAS Group company;
- permitted a single committee to be formed in respect of The PAS Group Limited to operate as the committee of inspection for each PAS Group company.

If the above resolution is passed, the Administrators do not intend to propose a resolution that a COI be appointed for any other company in the PAS group of companies.

If the above resolution is passed, the Administrators will propose a subsequent resolution appointing members to the COI.

Any creditor of a PAS Group company will be entitled to nominate and serve on the committee. Please contact the Administrators if you wish to nominate for the committee.

Creditors who have registered to attend the meeting are now required to recast their vote for the resolution (as proposed above).
