Please contact our office immediately if you have not received this letter.

As you may be aware, in circumstances such as these, the payment of unsecured creditors' accounts as at 6 July 2021 is deferred pending the satisfactory settlement of the debt of the secured creditor. We request, however, that creditors complete the attached form in relation to the amount claimed to be owing by the Company as at the date of our appointment and return it to our office at your earliest convenience.
