Notice of completion of sale of the PAS Group and retirement of Deed Administrators

We write to inform you that the Deed Administrators have completed a share sale of the PAS Group to PAS Group International Pty Ltd (the **Purchaser**) effective 1 February 2021.

We are extremely pleased that the PAS Group will carry on as a business in its current form. The Purchaser will write to you separately to introduce themselves. In the interim, your contacts in the PAS Group remain the same as prior to the sale.

The purpose of this letter is to explain what will happen with any outstanding invoices that you have with the PAS Group at 31 January 2021, and any invoices issued for goods or services provided from 1 February 2021 onwards.

1. Relevant entities

Specifically, this sale (**Second Transaction**) refers to the following trading entities:

- The PAS Group Limited
- Black Pepper Brands Pty Limited
- Review Australia Pty Limited

It also includes non-trading entities as listed in Appendix A.

We also sold the assets and the business of Designworks Clothing Company Pty Ltd and Yarra Trail Pty Limited on 30 November 2020 (**First Transaction**) and have previously written to the suppliers of these entities. Please refer to those letters regarding supplier procedures for these entities.

2. Goods and services provided from 1 February 2021 onwards

As per above, there is no major change to the operations of the trading entities. If you have any questions regarding ongoing supply, please contact your usual contact at the PAS Group.

The companies' details (i.e., company name, ABN, etc.) remain unchanged. However, the former Deed Administrators will not accept any liability for goods purchased or services rendered by suppliers after 31 January 2021. We therefore request you close the Deed Administrators' account and organise new accounts to be set up with the Purchaser.

Any valid invoices that you have outstanding as at close of business on 31 January 2021 will be paid by the PAS Group as and when they fall due, provided they relate to goods and/or services provided after 29 May 2020.

Additionally, the PAS Group will pay you directly for any invoices provided on or after 31 January 2021 which relate to goods or services provided during the period 29 May 2020 and 31 January 2021.

5. Pre-appointment invoices outstanding (prior to 29 May 2020)

We will write to all creditors as the Deed Administrators of The PAS Group Distribution Company Pty Ltd (Subject to Deed of Company Arrangement) (the **Distribution Company**) when we are in a position to declare a dividend to creditors. We expect to be able to do this by July 2021.

6. The Deed Administrators' role

We remain appointed as Deed Administrators over the Distribution Company for the purposes of:

- finalising the liabilities of the administration of the PAS Group from the period 29 May 2020 to 31 January 2021, and
- declaring a dividend to creditors for any pre-appointment claims outstanding (debts incurred prior to 29 May 2020).

Our appointment as Deed Administrators of the Distribution Company will have no impact on the operations of the PAS Group from 1 February 2021 onwards.
